**STUDENT INTERNET GUIDELINES:**

The Internet is a vast network, which links computers and iPads to many sites throughout the world. Using the Internet we can communicate with people all over the world, through electronic mail and by accessing vast amounts of information that have educational value.

At Clifton Springs Primary School we have Internet connections in each learning area, the staffroom and the administration area.

Access to the Internet by students will be through EDUSTAR.

EduStar also has some capacity to limit student access to inappropriate sites.

Access to the Internet by students will be supervised by teachers and will be for educational purposes only.

The purpose of these guidelines is to ensure that students at Clifton Springs Primary School who use the Internet & the CSPS Network do so in an appropriate manner.

1. Students will follow teacher instructions regarding the use of the Internet and the Network.
  2. Students will take great care with technology equipment in class.
  3. Student will be expected to behave responsibly and work cooperatively and conscientiously on the Internet and the Network and will not change any software configurations, including adding any unauthorised programs or files.
  4. When using the Internet, students will only access appropriate information, which is relevant to their work. They will make no attempt to access inappropriate material.
  5. Written consent has already been obtained from parents or guardians regarding student photographs, work or video footage being published on the Internet. It is the parent's responsibility to notify the office of any changes.
  6. Students will not change any software configurations, including adding any unauthorised programs or files.
  7. Students will turn off the computer or iPad monitor and inform the supervising teacher if they do access an inappropriate site.

## Internet Usage Agreement: Prep – Year 2

### This form covers your student's Internet usage from Prep to Year 2

All students and a parent/carer are required to read, understand and sign an Internet Usage Agreement at the commencement of each school year. This governs the requirements and expectations under which students use school technology, access the network and internet. This is a standard expectation, not only from Clifton Springs Primary School but also the Department of Education and Training (DET).

Parents/carers must be quite clear about the expectations within this Agreement and the consequences arising from it. The school will, of course, support students to understand how to care for their devices and to understand how to be responsible digital citizens.

1. I agree to follow all teacher instructions regarding the use of the Internet and the Network.
2. I will take great care with technology equipment in class.
3. I will behave responsibly and work cooperatively and conscientiously when using the Internet and the Network.
4. When using the Internet, I will only access appropriate information, which is relevant to my work. I will make no attempt to access inappropriate material.
5. I will turn off the computer or iPad monitor and inform the supervising teacher if I inadvertently access an inappropriate site.
